Our staff will be on the other hand being readily available with real-time positions of documentation as they flow through the clearance system.

Marine Security:

Following the ever unpredicted marine attacks and piracy threats in the

gulf, Swiftstrides Logistics has continued offering marine security services as agents.

With a global network of the Combat Anti-Piracy Security Forces, we professionally handle and provide the following services:-

- Receiving security personnel to accompany the weapons at the airport and making arrangements for accommodation and the hotel.
- Customs clearance and subsequent delivery of arms and ammunition both at Sea-freight and Air-freight Imports and Re-Export.

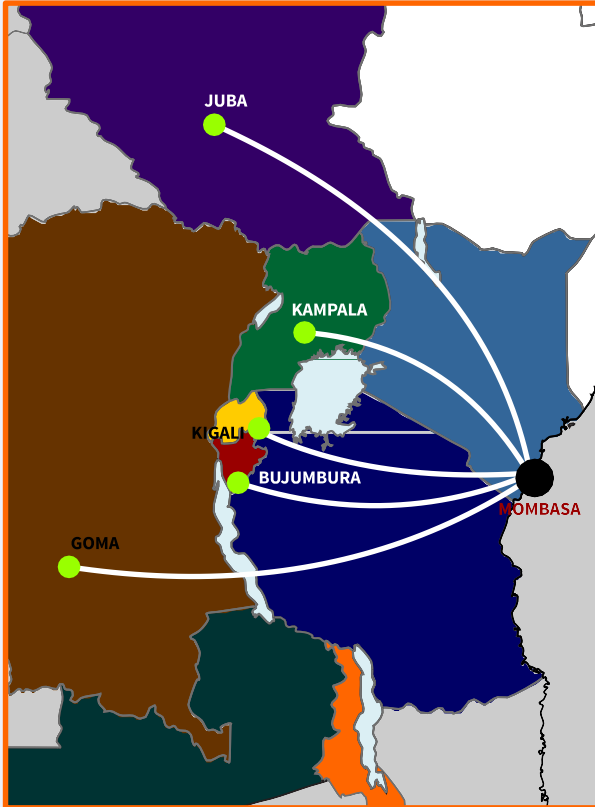

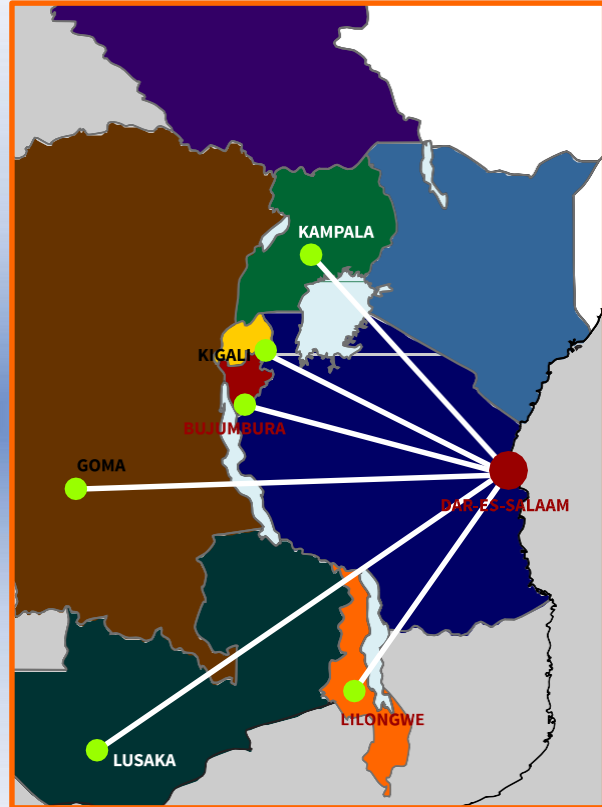
